ORDER:

In the Government order first read above, the Government have introduced the Tamil Nadu New Integrated Textile Policy, 2019 and in the Government order second read above, the detailed Guidelines for implementation of the Integrated Textile Policy was issued.

2. In letter fourth read above the Government have instructed to place the proposals received from the sectors viz, Spinning, Processing, Knitting, Apparel and Garmenting under Tamil Nadu New Integrated Textile Policy, 2019 before the Project Evaluation and recommendation Committee (PERC), which was already constituted under the Chairmanship of the Commissioner of Textiles to evaluate

the proposals for the Mini Textile Park Scheme in the Government Order third read above.

3. In the letter fifth read above, the Director of Textiles has submitted the following three proposal to the Government for sanction of 10% additional Capital Subsidy for Wider width fabric Printing Machines under Tamil Nadu New Integrated Textile Policy, 2019 as follows:

4. Further, the Director of Textiles has requested the Government to sanction an amount of Rs.71,60,000/- towards 10% additional Capital Subsidy for Wider width Fabric Printing Machines under Tamil Nadu New Integrated Textile Policy, 2019.

5. The Government after careful examination accept the proposal of Director of Textiles and accord sanction for a sum of Rs.71,60,000/- (Rupees Seventy One Lakh and Sixty Thousand only) towards 10% additional Capital Subsidy for Wider width Fabric Printing Machines under Tamil Nadu New Integrated Textile Policy, 2019.

6. The expenditure sanctioned in para 5 above shall be debited in the following head of account:-

"2852 Industries - 08 Consumer Industries - 202 Textiles - State's Expenditure - AL Capital Subsidy for Purchase of Wider width Fabric Printing Machine under New Integrated Textile Policy, 2019 - 311 - Subsidies 01 - individual Based Subsidy".

7. Necessary additional fund of Rs.71,60,000/- will be provided in RE/FMA 2024-2025. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2024-2025. Pending provision of such funds, the Director of Textiles is authorized to incur the expenditure sanctioned in para 5 above. The Director of Textiles is directed to include the above expenditure while sending the budget proposal for RE/FMA 2024-2025 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimates 2024-2025 to Government in Finance (Industries) Department at the appropriate time without fail.
